#### **Quarterly Community Policing Report**



Commissioner of Police Commands Community Oriented Police Enforcement (C.O.P.E.) Success Story 2017 Quarter One

While on routine patrol in the Seventh Precinct, COPE officers conducted a VTL stop near the intersection of Unqua Rd. and Sunrise Hwy. in Massapequa. Upon approaching the vehicle, officers did detect a strong odor of marijuana and observed marijuana crumbs scattered about the center console. Officers also observed a glass bong in plain sight on the rear seat of the vehicle. While questioning the occupants of the car, the rear driver's side passenger did produce an electronic cigarette containing concentrated cannabis and handed it to officers. The occupants were removed from the vehicle and frisked for officer safety. During a frisk of the operator of the vehicle, a hard metal object was felt in the defendant's jacket pocket. An electronic cigarette containing concentrated cannabis, along with a second cartridge containing concentrated cannabis was recovered. During further investigation, COPE officers did recover a small container from the defendant containing a small amount of concentrated cannabis. During a subsequent search of the vehicle, multiple packages containing concentrated cannabis were recovered from the passenger compartment. Officers also recovered approximately eight pounds of marijuana and numerous e-cigarette cartridges containing concentrated cannabis from the trunk of the vehicle, along with a briefcase containing over \$30,000.00 of U.S. currency. The defendants were placed under arrest and transported to the Seventh Precinct for processing. During an inventory search of the vehicle at the station house, a paper bag with multiple packages containing concentrated cannabis were also recovered.

## FIRST PRECINCT POP SUCCESS STORY

There have been numerous pedestrian robberies occurring in Uniondale in the vicinity of Hofstra University. There was also a gang-related homicide just outside of the Hofstra campus. The First Precinct POP unit contacted Hofstra's director of public safety, regarding a student who was the victim of an off-campus knifepoint robbery and to discuss student safety issues.

At the request of the director of public safety and the Hofstra athletic director, officers were asked to speak to the students in regard to safety awareness, off-campus living and the Social Host Law. On March 27, 2017, POP Officers John Bilello and Daniel Clarke spoke to 350 student athletes, coaches and staff, regarding off-campus safety. During this lecture, officers talked about gang activity in the Uniondale/Hempstead area and personal safety. For the student athletes living off campus, officers asked students to respect the surrounding community and to be good neighbors. For example, being consciously aware of noise, loud music, and parking legally would be displaying good neighbor traits. The Social Host Law was discussed at length, including the consequences and the liability it entails. Hopefully, educating the students will enable them to be more aware of their personal safety while off campus and to be better neighbors.

Also within the confines of the First Precinct, there were numerous complaints of speeding on Atlantic Avenue in Baldwin, between the Freeport/Baldwin Bridge and Baldwin/Oceanside Bridge. This has been an ongoing problem for many years. The complaints not only came from the residents, but from the Town Of Hempstead and a local Councilwoman's office. There have also been complaints of speeding near Baldwin High School. The POP unit performed vehicle traffic law (VTL) enforcement in both of those locations and issued numerous summonses for speeding. Several post cars participated in the enforcement as well. A speed trailer was then placed at both of these locations to make drivers' aware of their speeds. Speed limit signs at these locations through the Town of Hempstead, as well as solar speed signs to be installed on Grand Avenue in the vicinity of Baldwin High School with the posted speed school limit, were also requested.

The councilwoman's office sent a letter stating that there will be new 30-mph speed signs on Atlantic Avenue (displayed between the two bridges), and there will also be two solar school speed limit signs installed on Grand Avenue in Baldwin by the end of the school year. The First Precinct POP unit will continually monitor these problem areas and keep the post cars in the loop.

# Second Precinct POP (North) Success Story

A possible hazardous condition was brought to the attention of the POP office. The location was in Plainview at the off-ramp from East bound Route 495 to Sunnyside Boulevard. Tractor trailers and delivery trucks were parking on the shoulder of the roadway, and the operators were either sleeping in their vehicles or going into the nearby 7-11 store. Complaints were received from the staff, residents and visiting family members of the adult home that borders the long off-ramp with a connecting driveway to the adult home. Complaints included limited visibility and near collisions. Administrators at the home also noted noxious diesel fumes and noisy engines from long idling trucks. Local commuters also complained that traffic backs up during rush hour traffic because trucks are pulling on and off of the shoulder. Possible alternative solutions were discussed and evaluated among the POP officers, the post cars, the adult home administration and the 7-11 management.

It was decided that an outright ban of vehicles parking on the ramp shoulder would limit the store's income and prevent truck driver's from stopping there. Instead, it was proposed and agreed upon to have "No Stopping" signs placed on part of the shoulder, which would limit the number of vehicles that could park, and provide better visibility to those entering and leaving the adult home parking lot. Employees from the 7-11 said they would put signs up in their store and they would also advise the truck drivers that the police would be enforcing the new regulations. The post car operators and members of the POP office started off by warning truck drivers, thinking that word would spread to the other truckers that frequented the spot. After warnings, tickets were issued by department members and the number of violators and complaints diminished.

In March, Police Officer Michael Cammarata was advised of possible prostitution occurring at a residence in Old Bethpage. During the investigation, the officer discovered an advertisement on a website for massages at the location– stating a high class Japanese girl of your dreams with a perfect body will drive you crazy. Heavy vehicular traffic to and from the house was observed. The complainant stated that when the number in the ad from the website is called, the subject is told to drive to the street that the house is on, where a male Asian meets the customer outside and directs him to the exact location (a house that is set back off of the street with a long driveway).

After POP confirmed these observations by doing surveillance in an unmarked vehicle, they forwarded the information to the Narcotics/Vice Squad. On March 21st, squad officers called the number on the ad, and were told that the location for the massage was moved to a hotel in Hicksville. A sting was conducted at the hotel and an arrest was made. Since then, there hasn't been any more prostitution-related activity from the home, which has been vacated.

# THIRD PRECINCT (NORTH) POP SUCCESS STORY

On March 02, 2017, POP was contacted about a speeding vehicle condition on Mineola Avenue in Roslyn Estates. A meeting was set up for the following week. In attendance at the meeting were Officers Steven Krukowski and Daniel Hedgecock. The meeting took place at Torah Ohr of Roslyn, a local synagogue. Several members of the congregation were present at the meeting, as well as the Town of North Hempstead councilwoman.

A member of the synagogue had been killed while crossing Mineola Avenue a short time before, while walking home after a Sabbath service. This tragic accident had caused a great deal of concern for the community. The members of the synagogue had several concerns. One of the concerns was that a large dead tree was causing a blind spot for people leaving the driveway of the facility by car, and also on foot. It was difficult for them to see south bound traffic on Mineola Avenue. People walking to services had to walk into the street to get around the tree. Another concern of congregants was the lack of crosswalks in the area. They wanted a series of crosswalks installed so that people walking to services would have a safe path while crossing Mineola Avenue. They also requested timing boxes to be installed on the existing traffic signal light at Mineola Avenue and Warner Avenue. Their final complaint was that vehicles were constantly speeding south bound on Mineola Avenue. Enforcement, as well as a speed sign notifying motorists of their current speed was also requested.

After the meeting, Officer Krukowski, with the assistance of the Town of North Hempstead, contacted Nassau County's Department of Public Works (DPW) to see if any of the issues could be resolved. The tree was removed a short time later. Crosswalks and timing boxes would also be installed to assist with pedestrian crossings. A major overhaul of the intersection is also being considered. Officer Krukowski and Hedgecock have been enforcing the speed limit in the area on a regular basis and have written many VTL violations. Furthermore, a speed sign notifying motorists of their current speed is in the works with the Village of Roslyn and Roslyn Estates. Coordination between all of the agencies involved has made the intersection safer for all pedestrians. The synagogue has also given out bright yellow traffic vests for their congregants to wear while walking to services. The members of the synagogue and the POP Unit are in constant communication regarding the situation.





# THIRD PRECINCT (SOUTH) POP SUCCESS STORY

The Third Precinct POP office received phone calls and e-mails from the residents of Garden City complaining about commercial truck noise during all hours of the night. It was causing great annoyance and sleep deprivation in the community. Believing they had exhausted all options, residents called the POP unit as a last resort. During the early morning hours, specifically between 2 am and 6 am, residents were waking up to diesel tractor trailer engines idling on the commercial side of Brook Street. Residents believed most of the trucks were delivering to the Seviroli Foods, located on the corner of Oak Street and Brook Street in East Garden City, which is RMP 323's post.

The residential neighborhood borders a series of businesses in a commercial zone, which are separated by a wooden fence. The proximity of the trucks to the nearest residence, if parked at the fence line – is approximately 55 feet, making noise from the commercial zone more prominent. There is signage posted that says, "Restrict parking for loading zones only," to free up the area for vehicles loading and unloading goods. Other non-official, non-enforce-able signs are posted on various telephone poles, asking motor vehicle operators not to idle their vehicles. Seviroli Foods is the largest business on Brook Street and it operates seven days a week, 24 hours a day.

In an effort to inform the businesses of the problem and ask for their assistance, Officer Jesse Cooper attempted to contact the owner of Seviroli Foods. He received a return call from the store's logistics manager. He was very cooperative and agreed to work with POP officers to remedy the problem. The manager said he would direct his night manager to instruct all trucks affiliated with their business, not to park or idle at night, and welcomed the enforcement of parking restrictions. He also said that the business schedules all shipping and receiving of products, between 8 am and 4 pm. The officer suggested that the manager place one or two traffic barrels in the center of Brook Street with "NO IDLING" or "NO PARK-ING" lettering on them. He agreed with the suggestion and said he would have his night manager put them out each night. The conversation ended on a positive note.

POP Officer Cooper spoke to Town of Hempstead Traffic Control to inquire about idling infractions. Currently, the town has no idling infraction laws on the books. However, fur-

ther inquiry revealed, the Town of Hempstead has a commercial parking law stating: "No commercial parking overnight 0001 to 0600 on any public road." Currently, there is no signage posted on Brook Street stating that law. Per a request from the POP Unit, the Town of Hempstead dispatched a traffic safety representative to Brook Street to survey the area. The survey proved to be a success because the town approved new signage to be installed on the commercial length of Brook Street stating "NO COMMERCIAL PARKING 12:00 AM TO 6:00 AM."

A buck sheet was created by the Third Precinct clerk to instruct the night operators of RMP 323 and 324 to enforce overnight parking restrictions. POP Officer Cooper also spoke with the neighboring Garden City Police Department to make them aware of the issue.

As of this report, the POP Office has not received any further complaints. Upon installation of the signs and use of the traffic barrels, the violations will be clearly visible to truckers. This will also make it easier for the patrol officers to enforce and deter the trucks from idling. Post cars will continue to IP the area. #### Department Members in Attendance: Acting Police Commissioner Thomas C. Krumpter, Assistant Commissioner Patrick Ryder and Chief of Department Kevin Smith.

The community forum on NCPD police policy covered the importance of an open dialogue between the people of the county and the NCPD to help alleviate fears of deportation. Acting Commissioner Krumpter spoke about the NCPD's history and policy and its relationship with federal agencies, such as the Immigration and Customs Enforcement (ICE) agency, which enforces federal laws governing border control, customs, trade and immigration to promote homeland security and public safety. A representative from the Nassau County Assistant District Attorney's office assured residents that the NCPD does not "round up" undocumented immigrants, and stated that the NCPD is the only police department in the United States that has a special office for immigration affairs. Attendees expressed concerns about white vans picking people up. The commissioner said that ICE has only picked up two people in the county, and they were wanted felons that were previously deported. Assistant Commissioner Ryder added that the vans in question may have been NCPD warrant sweeps for people who didn't show up for court. There were several other speakers including a legislator and town supervisor. The ADA told the group that ICE is not authorized to conduct any activity in or near schools or churches. The commissioner answered that the only time a person would be asked about their immigration status is if they were arrested for a crime. Then, by law, the police have to ask about their immigration status and send the prisoner's information to ICE. Attendees were encouraged to visit www.ice.gov for more information about ICE.

A councilwoman from District #4 and her legislative aide requested two town hall meetings with the residents of both the Great Neck and Roslyn areas. # FOURTH PRECINCT POP SUCCESS STORY

In early March, the Fourth Precinct POP office received several complaints, via local residents and commercial business owners, about parking violations on Industrial Road in North Long Beach. POP Officers John Zanni and Greg O'Neill responded during a day tour to the location to scan and survey the road. Industrial Road runs parallel to Austin Boulevard and only commercial properties occupy the three-quarter mile stretch of roadway. The majority of the commercial businesses are auto body and collision repair shops. While surveying the area, officers observed several motor vehicles and trucks that were parked illegally and some lacked proper registration and inspection stickers. They also observed several commercial properties with unkempt property with vehicles stacked on top of each other in an unsafe and hazardous manner. Instead of issuing summonses for the parking violations, Officers Zanni and O'Neill spent the day meeting with several owners of the businesses on the road. Through these productive and informative conversations, the Fourth Precinct POP team was able to learn about the business owners' frustrations in regard to inadequate spaces for employee parking, a small work area to repair autos and a lack of space to store all of their vehicles. Officers Zanni and O'Neill were also able to identify the business owners who were responsible for the illegally parked and abandoned automobiles. They spent time educating the business owners about parking violations and abandoned vehicles and the importance of keeping the roadway clear. The officers asked the business owners to remove all abandoned motor vehicles from the street within the week and to abide by New York State and Town of Hempstead (TOH) parking rules and regulations. All of the business owners were also notified that the area would be revisited and there would be enforcement for illegally parked or abandoned vehicles on the street.

The following week, POP notified the TOH Highway and Building Department to inform them about the conditions on Industrial Rd. Officers Zanni and O'Neill worked closely with the TOH assistant supervisor. Together, a plan was formulated to address the parking conditions and the building code violations. The town agreed to lend assistance by providing tow trucks to remove any abandoned vehicles and assign enforcement officials to address any code violations.

On March 22nd, the Fourth Precinct POP Team, accompanied by TOH officials, conducted a sweep on Industrial Blvd. The team identified six vehicles that were deemed abandoned. PDCN Form 105 was completed by POP and the six abandoned vehicles were removed from the street by TOH tow trucks. They were transported to a secure lot. Town officials also issued several warnings and tickets to business owners for unkempt property and other building code violations.

By applying the scanning, analysis, response and evaluation (SARA) model, the POP Unit was able to successfully address all issues and concerns on Industrial Rd. POP will continue to monitor the situation – working with the post cars and the town and business owners – in order to keep the roadway clean and safe.

# FIFTH PRECINCT POP SUCCESS STORY

The Fifth Precinct patrol officers received several 911 calls from two residential homes in Elmont regarding a neighbor dispute. From June 2015 until March 2017, there were more than five 911 calls made. Both residential parties were referred to the Fifth Precinct POP Office. Officers reached out to both families and met with each family separately to analyze the situation. Officers also visited the block several times to observe the houses, the properties, and to observe the conditions that seemed to be causing the conflicts and animosity between both families. The neighbors were arguing over several issues. However, a main issue involved parking. Although both families have their own driveways, side by side, they share a common driveway, or apron, in their cul-de-sac. Several of the disputes have been in relation to cars blocking the common apron. Officers also spoke with Fifth Precinct patrol officers who had responded to several 911 calls, and determined that a resolution could not be implemented. Then, POP met with both families at the Fifth Precinct Station House. They were both willing to be a part of this process. It was a controlled atmosphere and both families were respectful of each other and listened to each other's concerns and complaints. A plan was formulized to move forward. Both parties agreed to talk to their friends and guests about blocking the driveway. They also agreed not to call 911 unnecessarily on each other. Officers also made a referral to the EAC Long Island Dispute Resolution Center.

Since then, there have been no 911 calls. POP reached out to both families and was told there have been no further issues.

# SEVENTH PRECINCT POP SUCCESS STORY

POP officers received numerous complaints regarding a problem house in Bellmore. An investigation revealed that the home had been in foreclosure for some time, since the homeowner had passed away. The homeowner's son, continued to live in the house with his friends. Complaints of narcotics, prostitution, local larcenies from autos, late night noise, and suspicious persons increased from the neighboring homes. POP officers filed intelligence reports, which put the house on the radar of the Vice and Narcotics Squads, and the homeowner's son was arrested and incarcerated. Friends continued to occupy the house, and POP had no authority to evict anyone without having a complainant to begin the eviction process. POP officers contacted the TOH, who responded with summonses for unkempt property. It was not enough to deter the occupants, and complaints from the neighbors continued. POP Officers responded to the house with TOH code enforcement agents and were able to convince an upstairs tenant to allow an inspection of the premise for her own safety. Upon visual inspection, it was discovered that the apartment had illegal connections to electricity, there was no hot water and no heat. The house was deemed uninhabitable, and there was an immediate emergency evacuation of all residents. The house was boarded up, and the residents were warned that any attempt to return to the property without an escort by the TOH or the police would result in an arrest. The residents of the house have not returned, and the local neighbors have expressed constant appreciation for the positive change in their neighborhood.
