### FIRST PRECINCT POP SUCCESS STORY

First Precinct POP Officers Anthony Natale and Anthony Dalto visited the principal of the Lenox Elementary School in Baldwin. She spoke about parking issues on the streets surrounding the school and traffic congestion that occurs during student drop-off and pick-up times.

After the meeting, the officers parked outside of the school to observe the traffic conditions. They saw parents making U-turns on Sylvia Avenue, which was stopping the flow of traffic and causing congestion. They also observed a section along the curb on Sylvia Avenue that prohibited vehicles from stopping, with the exception of school buses. There is no bus service at this location anymore. The old signage limited the amount of curb space parents could use to pick up or drop off their children, which then caused more congestion in the streets.

Officer's Natale and Dalto decided to recommend that "No U-turn" signs be installed on Sylva Avenue and that the "School Buses Only" sign be removed. They contacted the local councilwoman's office, who then contacted the Town of Hempstead's Office of the Town Attorney, Traffic Control Division. The request was made, and the changes were made. The officers asked the principal to send a letter to the parents informing them of the changes and they continued to observe the location for several weeks to ensure compliance.

The changes that were implemented, along with educating the parents about the new rules governing the traffic patterns, and continued intensive patrol (IP) at the school corrected the congestion problems. This has allowed for quicker and safer pickups and drop offs of the students.

The officers surveyed the clubs, checked the camera systems, and club procedures for members entering and exiting the club and locker rooms. POP officers obtained a copy of their usage reports when the larcenies were committed. A break in the cases occurred when a subject was arrested in the First Precinct. He was in possession of a stolen credit card that was taken from the location in Hicksville. The subject admitted to other larcenies at that location. POP officers discovered that the subject was in fact a gym member of the Hicksville location. After reviewing the usage reports, the subject had been in the Hicksville gym during the larcenies. The one case involving the Syosset location revealed that the subject showed up at that location and was permitted to work out at there as a courtesy since his membership was exclusively for the Hicksville location.



## Second Precinct POP (South) Success Story

In April, POP officers met with the managers of all the gyms located within their precinct regarding the trend of larcenies from gym lockers. Officers brainstormed with the managers and discussed ways to curtail the thefts. Managers were given flyers to hang in the locker room, which gave tips to patrons about how to secure their valuables. Managers were also shown pictures of gym larceny subjects from throughout the county and were told to be on the lookout for them. Since the meeting with gym management, there has been a significant reduction in larcenies from gym lockers.

Additionally, there have been multiple vehicle accidents and a few fatalities at the intersection of Fulton Street (Route 109) and Main Street in Farmingdale. Pop officers made key observations of the intersection's layout, the timing of the traffic lights, the speed and flow of pedestrian and vehicular traffic, etc. The Pop Unit, along with various officers from the precinct and other units, issued numerous summonses and warnings to pedestrians and motorists at the location. The Pop officers made suggestions to improve the timing of the traffic lights, and to add a left-turn, red arrow as many accidents are left-turn accidents with limited visibility.

Furthermore, the precinct has been inundated with grand larcenies from car dealerships involving tires and rims. The Pop Unit reached out and met with dealership management and discussed target hardening strategies. Many dealerships had lots with hundreds of vehicles where there was no security, no cameras, unsecured or no perimeter fencing, etc. Advice was given to management on ways to put a dent in this growing trend of tire and rim theft, with positive feedback. Since the meetings, there has been a slowdown of larcenies of tire and rims, and the Pop Unit will continue to monitor the pattern.

Officer Steven Krukowski met with approximately 35 members of the organization at Cutter Mill Park on June 20th. The group had a multitude of complaints about after hour activities going on. They said even though there were posted signs stating that the park closes at 9:00 p.m., people were not leaving by then. Complainants said large groups of youths congregated in the park after 9:00 p.m., and they made a lot of noise, and drank alcohol directly along the fence line of the park where it borders the residents' yards. They could hear loud music being played as well.

Furthermore, the youths were parking their vehicles on Tobin Avenue, which is a dead- end street at the park's entrance. They made a lot of noise coming in and out of the park and speed down the dead-end street, according to the neighbors.

The group asked for suggestions from the POP Unit. The first thing Officer Krukowski did was notify the Great Necks Parks district security supervisor of the problem and he immediately increased patrols in the area. The Third Precinct North post car was also notified of the situation by Deputy Inspector Greg Abruzzo, and they began intensive patrols of the park after 9:00 p.m. Officer Krukowski also proposed increased lighting in the blind areas of the park to the park district. After careful analysis, it was determined that the park could use more lighting to keep the youths from congregating in the darker areas along the property line. The Town of North Hempstead (T.O.N.H.) was contacted to request additional signage at the entrance of the park. More "Dead End" and "No Outlet" signs will be added to let motorists know that this is a dead-end street, and there is no access to any other roadway. This will hopefully cut down on the volume of traffic. No parking signs near the park are also under consideration. The signs have been approved and ordered by the T.O.N.H.

After all the above mentioned changes were implemented, a follow-up call to the civic association confirmed that the youths have not been back in the park. The situation has been resolved. The officer will keep in touch with the parks department, residents and the T.O.N.H. to make sure the situation remains corrected.

## THIRD PRECINCT (SOUTH) POP SUCCESS STORY

The Third Precinct POP office received a call from the facilities manager of a Jewish Center. He expressed concern about a problem the center has been having for years, with an unknown person, feeding and placing make-shift cat shelters on and around properties belonging to the center. The Jewish Center has been unsuccessful in past attempts to stop this activity and requested the help of the Third Precinct POP officers.

Within the center are a preschool, a day care center, and a temple. There is also a catering hall used for meetings and events. A fence borders portions of the Jewish Center, while other parts are open. There are a small group of residential homes on the northeast border that are owned by the Jewish Center, and are reserved for the acting rabbi and cantor. Across from the center is a wooded marsh area owned by the Town of North Hempstead. Cat shelters are mostly placed on the side and rear of the homes used by the rabbi and cantor. A large number of shelters were found in the marsh area across the street from the residential neighborhood. The cat shelters in the marsh area were of no concern to residents or the center.

POP Officers Cooper and Atkin walked through the properties with the center's facility manager and found and removed multiple shelters. The manager said no one had been given permission to place cat shelters on the property. POP officers received license plate information from the manager who described the subject as a 30-year-old female operating a blue Toyota. He asked the officers to warn the subject and then if she continued, he would sign a 32b to secure an arrest for trespassing.

POP officers used the plate information to respond to the subject's residence multiple times without success. Several weeks later, Police Officer Cooper received a call from the manager advising that the subject had returned and was being observed from his security camera. POP Officers Atkin and Cooper responded immediately and pulled up behind the vehicle matching the license plate provided. The car was parked illegally and the officers observed a female in the swamp area placing new cat shelters and removing old ones. Officers approached the subject and verified her identity. She admitted her involvement in the placement of the cat shelters on the North Hempstead property and the property belonging to the Jewish Center. She stated her mission was to shelter and feed the stray cats and that she is a member of People for the Ethical Treatment of Animals (P.E.T.A.). She also stated that she had captured many cats and brought them to be spayed or neutered and then returned them

to the area. POP officers commended her on her good work and then advised her that she could continue her work on North Hempstead property. However, she was not authorized to enter the Jewish Center property. At first, she was uncooperative, and said she would continue to shelter and feed the cats, claiming she had previous permission from the residents. Officers then advised her that their complainant's authority superseded any verbal permission she allegedly received, and he is prepared to file trespassing charges against her if she enters onto the Jewish Center property again. Officer Atkin also explained that she may be in violation of local ordinances by leaving food out because it affects the quality of life and attracts other unwanted wildlife. Officer Cooper also advised her to get permission in writing if she attempts to place cat shelters on private property. She became cooperative and promised to stay off the property.

As of this report, no more cat shelters have been placed on the property of the Jewish Center. POP Officers Atkin and Cooper continue to monitor the situation to ensure continued success.

# FOURTH PRECINCT POP SUCCESS STORY

Late in 2016, Fourth Precinct POP Officers were contacted by the athletic director from Lawrence High School. # SEVENTH PRECINCT POP SUCCESS STORY

POP officers were contacted by a group of neighbors from a small block in South Massapequa. The neighbors came together to discuss difficulties they were having with one neighbor playing loud music that is crossing property boundaries and affecting all neighbors with adjoining yards and beyond. POP Officers made several attempts to contact the family without success. Neighbors were told to continue to call 911 when this neighbor was in violation of noise ordinances. While on routine patrol, POP officers heard an assignment go out to post cars for a noise violation to the subject's address. POP Officers intercepted the call and responded to the house. The homeowner was not very receptive or cooperative at first, but the officers were able to develop a rapport with him. The homeowner showed the officers his automated music system and the officers worked with him to set up an acceptable volume of music, which he agreed to maintain for peace in the neighborhood. POP Officers initiated a follow up when they contacted the homeowner via phone to again thank him for his cooperation. The homeowner was pleased with how the officers related to him and how the NCPD handled the situation. He took it upon himself to cooperate further by installing a new speaker system, which faced only his house and would no longer project into adjoining neighbors' yards. Neighbors have called to thank the POP Office on several occasions - expressing relief from this ongoing dilemma.
