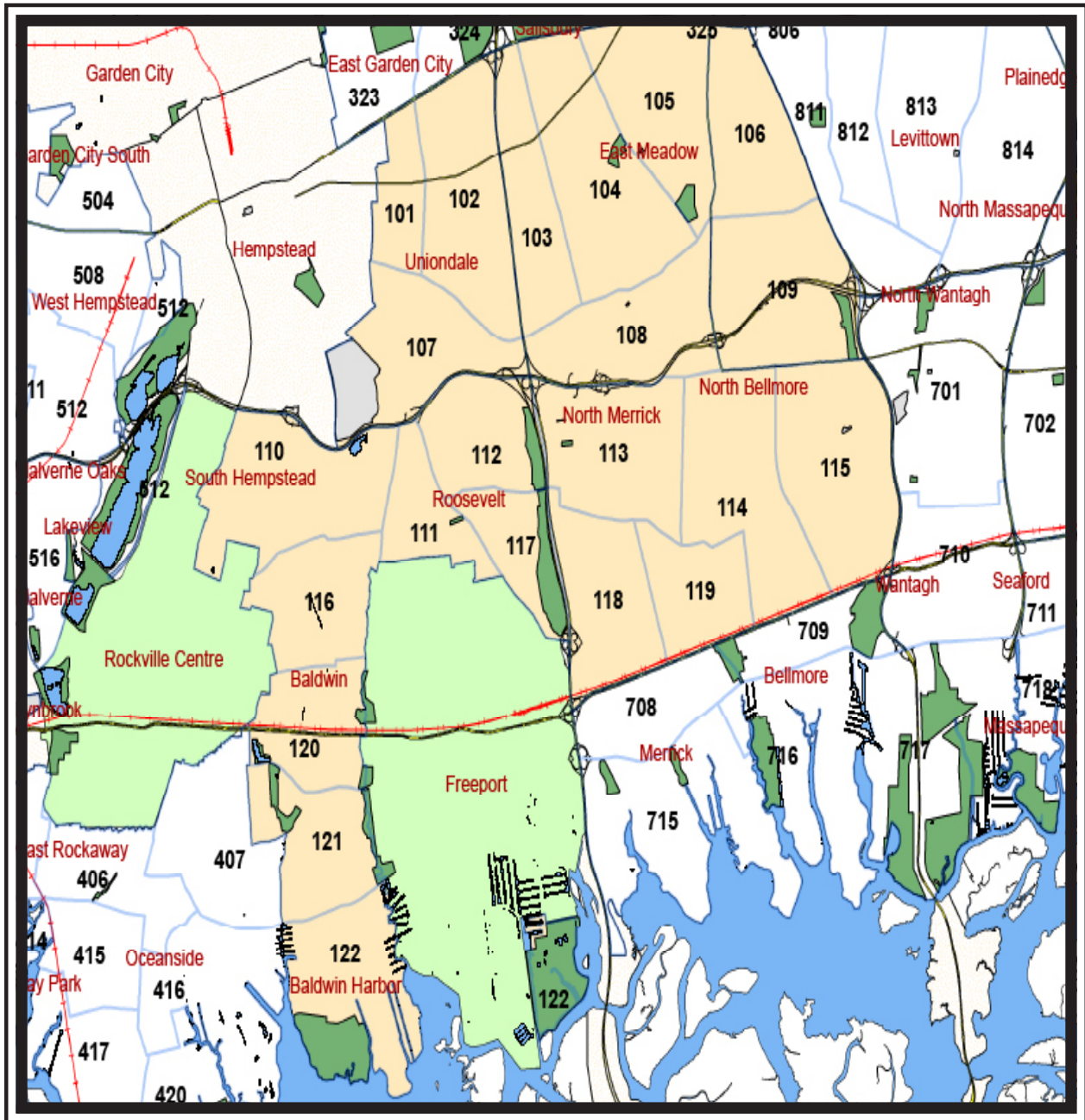

FIRST PRECINCT POP SUCCESS STORY

The First Precinct POP Office received a complaint from a Town of Hempstead Councilwoman. The complaint was about a house in Bellmore. Neighbors complained that the homeowner has several vehicles on his property and in the street, which he uses for his business of picking items and selling them at garage sales. The homeowner also stores some of these items on his property. The complainants have stated that this has caused a problem in their neighborhood and they requested the POP Unit's assistance.

After speaking with some of the neighbors about their complaints, POP Officer Daniel Clarke responded to the above listed address to assess the situation. He observed that the vehicles that belonged to the subject that were parked in the street were all properly registered and inspected. These vehicles were also parked legally and not violating any parking restrictions.

At this time, the Officer Clarke got a chance to speak to the homeowner. He told the homeowner about his neighbors' complaints regarding the way he was keeping his property. Officer Clarke also observed items cluttered all over the property. The homeowner said these are items that he has collected and sells at rummage sales. PO Clarke advised the homeowner that he is not able to keep his property in this cluttered condition and POP would return with the TOH Building Dept. if he didn't clean it up.

Officer Clarke returned a few days later with a code enforcement officer from the TOH. The enforcement officer said he had dealt with the homeowner in the past. After inspecting the property, the homeowner was issued several summonses requiring him to clean up his property. Adult Protective Services was also contacted to see if they could assist the homeowner.

To date, the situation is being monitored and the TOH is working with Officer Clarke on this matter.

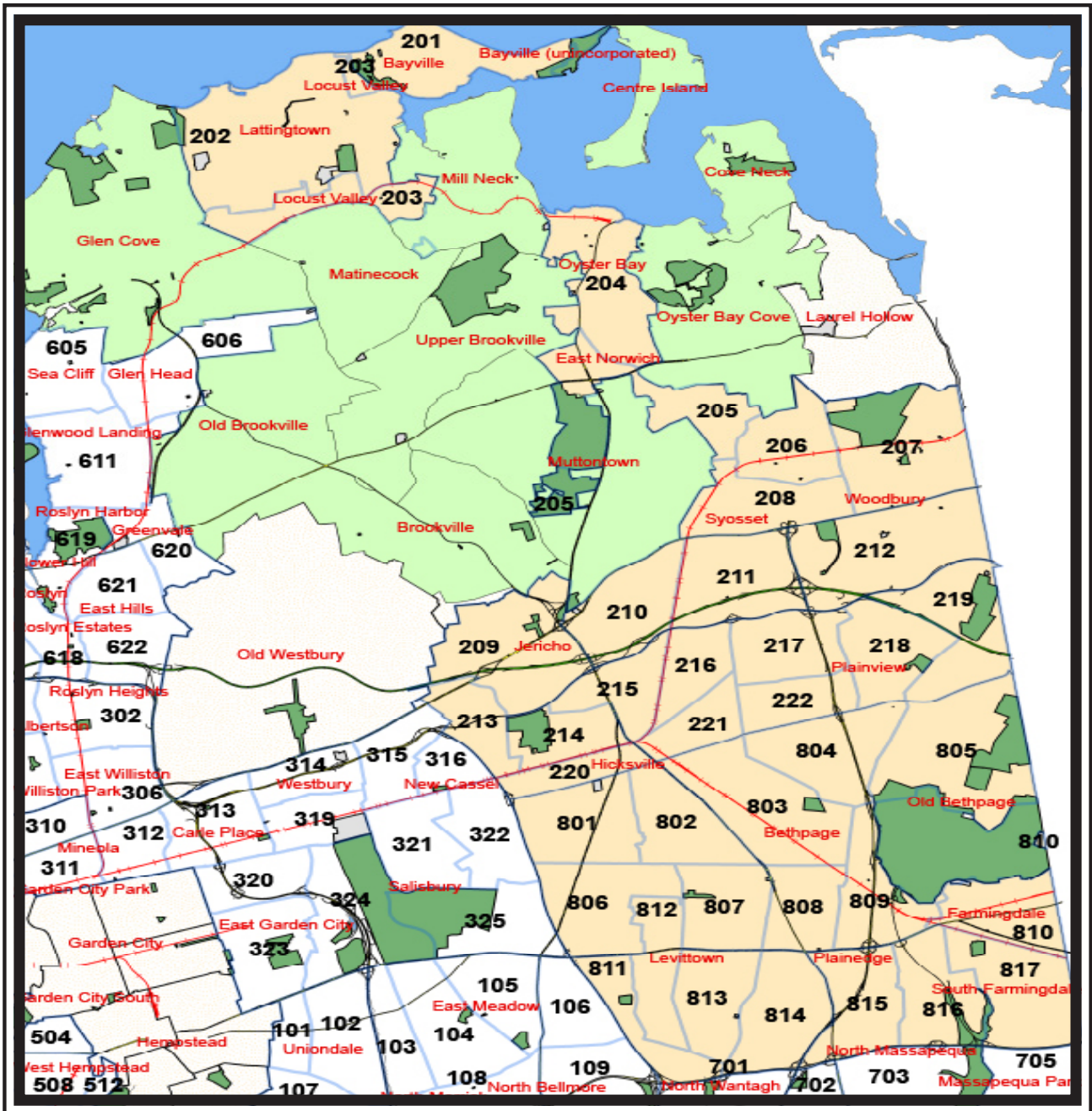

SECOND PRECINCT POP (NORTH) SUCCESS STORY

In May, the POP Unit investigated a complaint about a homeowner that was allegedly leaving large quantities of food in his backyard. Consequently, squirrels raccoons, and other wildlife were frequenting his property. Defecating birds, bugs and flies were also a problem, which was creating a health hazard and unsanitary conditions for some neighboring properties.

After collaborating with the town of Oyster Bay Code Enforcement Unit, the homeowner was found guilty in Fourth District Court for failing to maintain grounds free of insect, vermin and rodent harborage and infestation. He was ordered to stop feeding the animals and was subject to random checkups by the town building inspector.

The POP Unit was then notified again later in the same month that the situation was still ongoing. Officers conducted surveillance on the property on different dates and times, observed the feeding violations, secured case reports from the victims, took photos and re-contacted the Town of Oyster Bay Code Enforcement Unit and the town attorney. Upon completion of the investigation, the homeowner was issued two appearance tickets for violating the directives of the Fourth District Court. The POP Unit also coordinated with the town to have an inspection of the property, which resulted in the homeowner being in violation of the previous court directives. The homeowner will appear in Fourth District Court again to answer the latest charges.

SECOND PRECINCT POP (SOUTH) SUCCESS STORY

The Second Precinct South POP Unit observed a complaint via social media in regard to a possible illegally erected clothing drop box bin located on private property. There were many complaints about the post as the bin became an eyesore to the residents and they were worried that the box was being used for illegitimate reasons. The POP Unit responded to the area of concern and observed a blue box made of plywood with "Clothing Drop Box" spray painted on in along with a phone number. There were no other markings, company name, or permits on it. The POP Unit first called the number listed and the person who answered could not answer any investigative questions. The POP Unit then called the Town of Oyster Bay Clerk to see if any permits were given out for the location, which was negative. POP Officers then spoke to the landlord of the property and notified him of the situation and the possibility of a summons if he allowed the clothing bin on his property. The landlord said he appreciated the notification, and he said he would have it removed immediately.

The following day, the POP Unit responded back to the location to find that the illegal clothing bin had been removed. A few days later, officers learned through social media that the clothing bin had been erected again, but this time it was moved a few hundred feet off of the private property onto county property near a water basin. The POP Unit observed the bin for a couple of days to see if anyone came by to empty the bin, but there were no items placed in the bin. The POP Unit then contacted the County Department of Public Works to request the removal of the illegal clothing bin, and it was removed immediately. The POP Unit continued to monitor social media and observe the area of concern and the clothing bin has not been erected again.

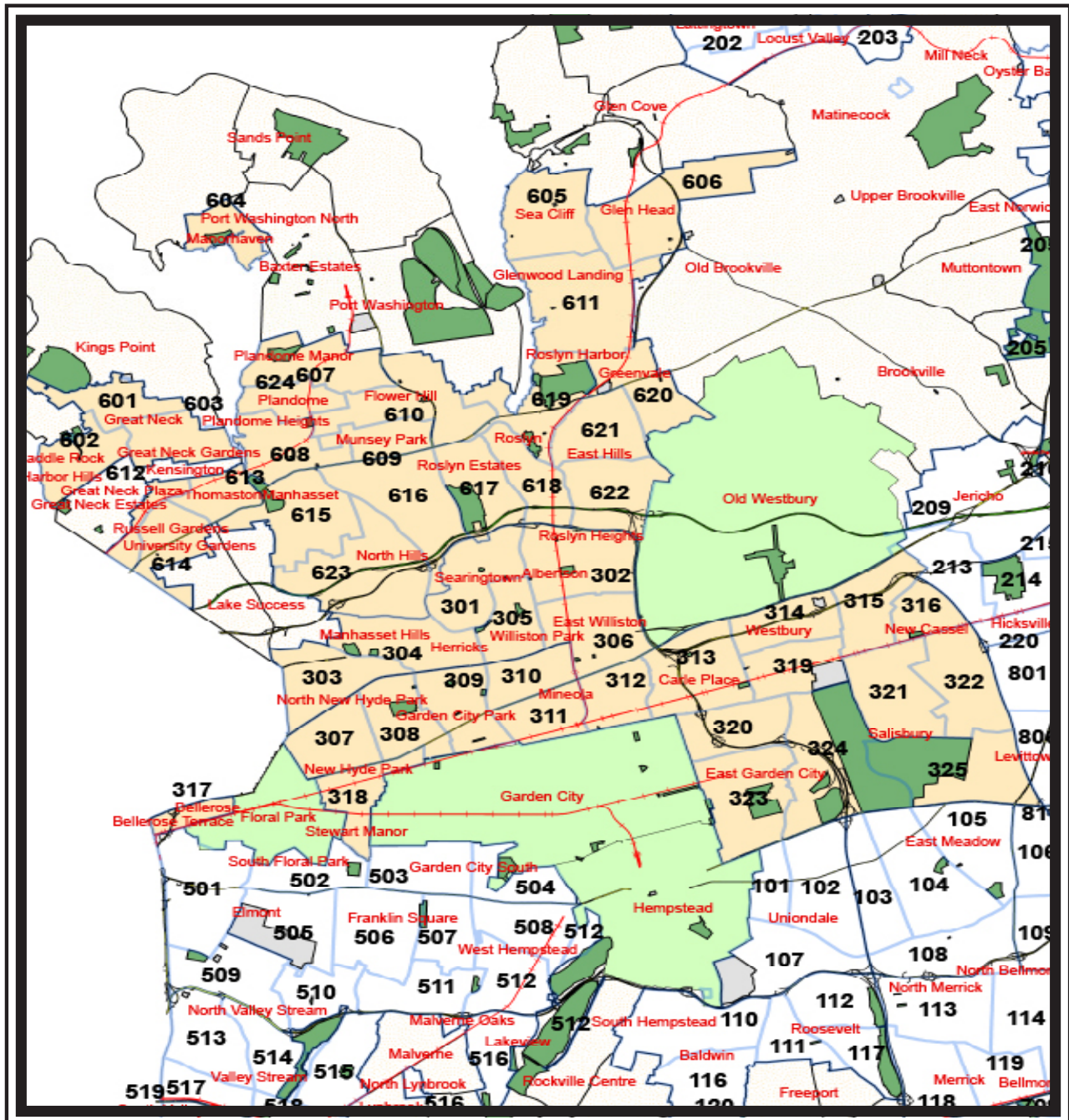

THIRD PRECINCT (NORTH) POP SUCCESS STORY

Third PCT North POP Officers received multiple complaints for vehicles traveling at a high rate of speed in an area where children were present. There were also complaints of illegal turns in violation of signs at the intersection of Jessica Place and Old Powerhouse Road in Roslyn Heights during rush hour. The residents that live on Jessica Place were concerned about the volume of vehicular traffic and the violations that had been consistently occurring for an extended period of time. The residents stated that previous efforts had not been effective in mitigating the violations and they were requesting action be taken.

The complainants spoke with the Third Precinct POP officers and provided them with detailed information including times and types of violations. The POP officers began communicating with the Third Precinct enforcement officer and reached out directly to post cars and the enforcement unit on a consistent basis to address the ongoing issues. The post cars, adjoining post cars and enforcement unit worked tirelessly to address these concerns by issuing summonses when violations were observed and by creating a visible presence.

The complainants reached out to the POP office on numerous occasions this month expressing their appreciation for the NCPD's efforts. The POP office is continuing to review the location and further address the concerns to make the residents feel comfortable and safe.

THIRD PRECINCT (SOUTH) POP SUCCESS STORY

The Third Precinct Pop Unit was contacted by the East Williston School District to address some safety concerns with the North Side Elementary School. The principal, as well as the board of education, was concerned for the safety of the students while using the school grounds for recess and physical education due to high speed traffic and unrestricted access by the public.

The school is located in East Williston and faces East Williston Avenue. It is a double yellow line road with high volumes of traffic with a posted school speed limit of 20 MPH during school days and 30 MPH on off hours and non-school days. With the exception of a few trees and telephone poles, there are no traffic safety measures in place to deter or prevent a vehicle from simply driving onto the property and coming into contact with the school. The principal also advised the POP officers of a homeless man that occasionally wanders onto the school grounds, sometimes while the kids were out during recess. There is no wall or fence surrounding the school to prevent an intruder from walking onto school grounds or vice versa – preventing a child from running off, possibly into traffic. Currently there is no measure of protection or barrier to protect the children. This places the school, faculty and most importantly, the students at risk.

POP Officers Cooper and Atkin dedicated themselves to helping the school succeed with their safety goals. Officer Cooper responded to the school on multiple dates and conducted speed enforcement on East Williston Avenue – issuing multiple summonses to violators. POP officers conducted extra visits to the school and also notified the post cars to do extra patrols during the times when the homeless man has been known to appear. PO Atkin and PO Cooper attended a training conducted by the Nassau County Department of Homeland Security, enabling them to assess the safety of the school building and grounds. As a result, POP officers conducted a security survey of the entire school and generated a report with assessments and suggestions on security systems and procedures. The report also highlighted the benefits of a security fence and suggested a small decorative retaining wall that would maintain the beauty of the area while providing a barrier from oncoming traffic. POP Officers Cooper and Atkin also attended multiple safety meetings and school board meetings to discuss the security issues involving the North Side School. POP assisted the school board by speaking publicly at one of their meetings and answering many of the residents' questions and concerns.

As a result of the security survey and the efforts of the POP Unit, the district approved the construction of a new fence and retaining wall for the North Side School, as well as some other upgrades and improvements that were suggested in the report. These Improvements will greatly enhance the safety and security of the children and create a constant deterrent against potential threats. POP officers, with the assistance of the Nassau County Department of Homeland Security, will continue to work with the school district, attend safety meetings and public school board meetings, answer questions and provide feedback. POP will also assist during the planning stages and construction of the new security measures.

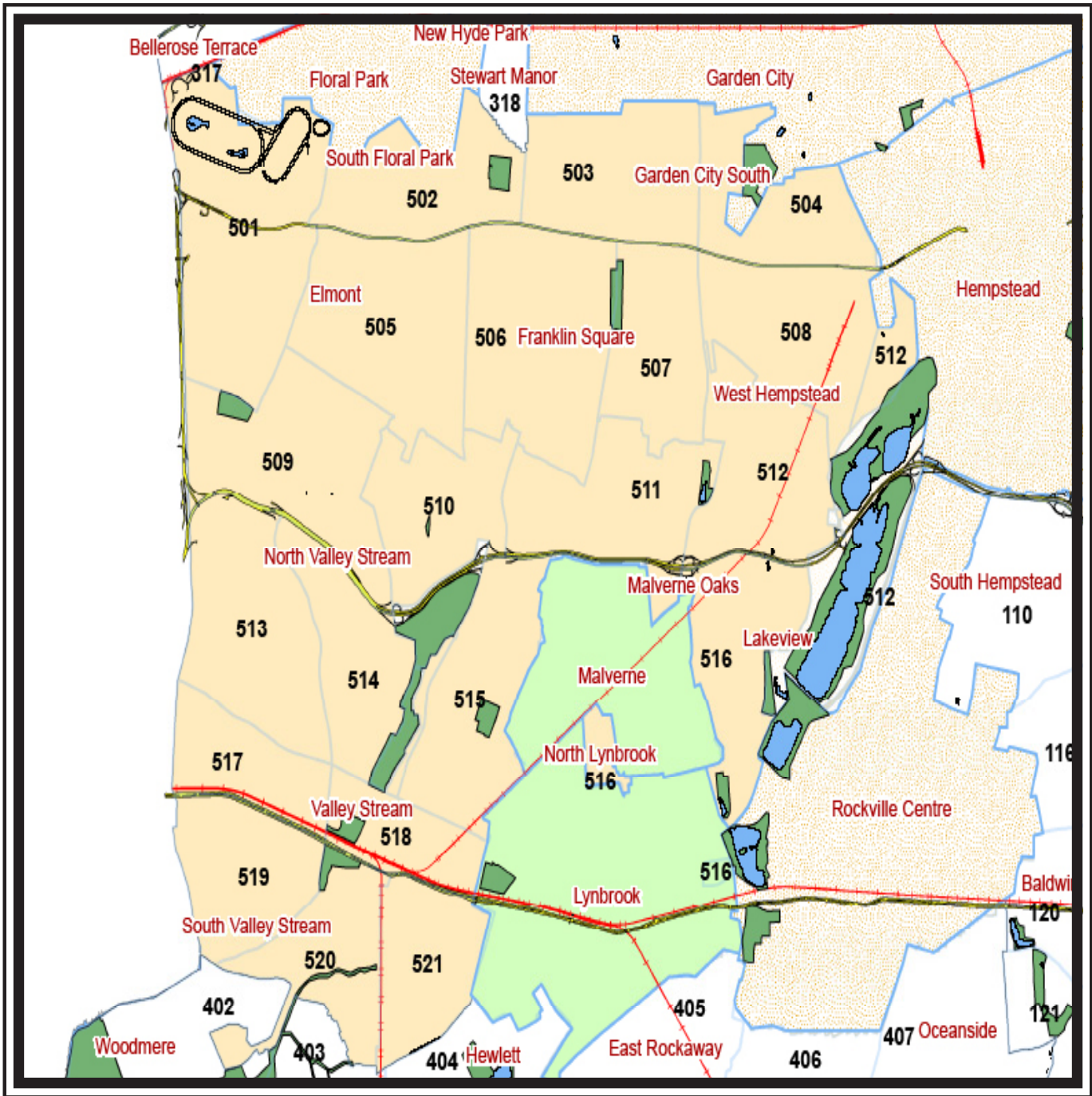

FIFTH PRECINCT POP SUCCESS STORY

The POP Unit received notification of an autistic and learning disabled child who was reported missing by his parents. The child had been reported missing before and was considered a high risk because of his poor medical condition – he was taking several medications. The child was wearing a monitor on his leg, which was issued by the Malvern Police Department, as part of the Life Saver Project.

The parents discovered that he was missing in the middle of the night, and the temperature outside was below freezing. Due to the severity of the weather and the circumstances, all of the NCPD's resources were used to their full capacity, which included all Fifth Precinct patrol officers, patrol officers from other commands, the K9, Aviation, and Emergency Service Units, the Lynbrook PD, Malverne PD, Fifth Precinct Squad, Missing Persons, PIO, recruits, Police Explorers, Community Affairs and hundreds of volunteers from the community – all involved in the search. Fifteen hours later, the child was located in the backyard of a neighbor's house hiding in a shed, and he was immediately brought to Winthrop Hospital for medical attention.

POP Officers Diaz and Bopp-Carroll met with the parents at their home following the incident to check on the child's condition and to discuss the event. At that time, the child was undergoing a psychiatric evaluation at a local hospital. During the meeting, officers found out that the child's monitor was not working because the battery was dead and the parents didn't know how to change it or where to get new batteries. The officers reached out to Missing Persons to go over the procedure and to get them the batteries they needed for the monitor and to train the parents to prevent this scenario from happening again. Officers also made several suggestions – adding additional layers of security to their home. The parents had a new security system installed and the child's bedroom door and windows contained sensors. They also purchased a GPS watch for the child and were looking into purchasing a bed with an alarm at the officer's suggestion. There haven't been any other incidents since all of the additional levels of security were implemented.

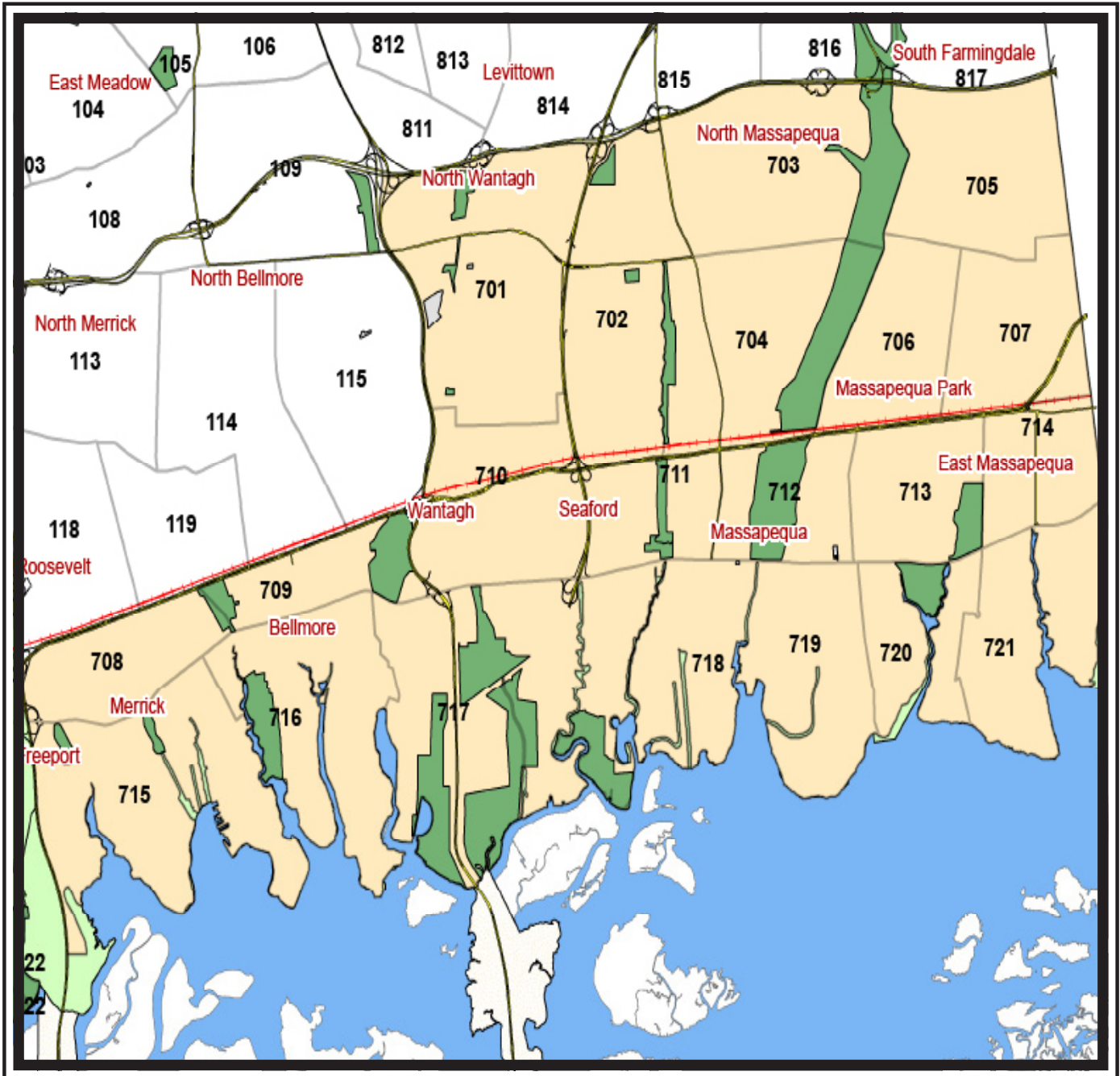

SEVENTH PRECINCT POP SUCCESS STORY

Seventh Precinct POP Officers worked in conjunction with the general manager and security director of the Westfield Sunrise Mall in Massapequa to establish the “Coffee with a Cop” Program. The program, sponsored by Starbucks, would be promoted by the Westfield Sunrise Mall’s management and would be held as a monthly event. The first “Coffee with a Cop” event was held on April 10th at 9 a.m. POP Officer Steve Russell attended the event, along with the general manager and security director of the mall. During the program, a wide variety of police-related topics and questions were addressed with mall patrons and employees.

The sunglasses, valued at \$725, were recovered, and the subject was led back to the store where assistance was requested to respond. The subject was charged with one count of petit larceny, and was found to have an open warrant from Suffolk County for petit larceny.

The inaugural “Coffee with a Cop” program was an informative, successful, and productive day for all of those involved.
