



PART-TIME CROSSING GUARD NASSAU COUNTY, NEW YORK

The Nassau County Police Department is currently seeking Part-time Crossing Guards for assignments throughout Nassau County.

Qualifications are:

- ✎ Nassau County residency required.
- ✎ Candidates must be able to direct pedestrian and vehicular traffic at specified locations for the purpose of protecting children and other persons in the vicinity of a school crossing or other assigned crossings.
- ✎ Candidates must be able to speak clearly and effectively in English with children, parents, motorists and other adults. Must be able to give directions and maintain control of children. Must be able to read and write English and be able to complete basic Police Department forms without assistance.
- ✎ Candidates must be able to report for work on a daily basis and function efficiently throughout an entire work shift without interruption. Candidate must have the ability to travel to an assigned post in a timely fashion without departmental assistance. Candidate must be able to adjust for changing irregular hours and be able to work weekends and holidays as assigned.
- ✎ Candidates must be able to withstand varied environmental conditions including extreme heat, cold, moisture and low light conditions. The described position requires a level of physical ability to include vision, hearing, speaking, flexibility and strength.
- ✎ Starting salary for this position is \$ 18.00 per hour with no fringe benefits. This part time position can require up to 17 hours per week.
- ✎ Candidates must have graduated High School.
